#### **MOTIONS**

1. Commissioner Zimmerman made the motion and Marge Fox the second to approve the minutes from November 15, 2018. Vote unanimous.

## **SECURITY**

- 1. No reportable extraordinary occurrence reports (EOR) submitted to the Pennsylvania Department of Corrections for the month of November 20, 2018.
- 2. The facility issued fifteen (15) major misconducts and seventeen (17) minor misconducts for the month of November.

#### **TREATMENT**

#### **STAFFING**

#### **MAINTENANCE**

- Maintenance Crew has completed a number of in-house projects which included constructing a ramp for the walk through metal detector similar to the ramps used by the Commonwealth.
   This ramp places foot ware within the detection field. All staff are being processed through the metal detector upon entrance into the facility with all bags being checked by the on shift supervisor.
- 2. The lighting enhancement project is moving forward, Mr. Ziefel has installed a number of high lumen LED lights and will finish with the yard perimeter fencing.

## **FINANCIAL REPORT**

- 1. Fayette County paid \$4,700.00 for the month of October 2018 in regards to rental fees and owes \$6,650.00 for the month of November. The rental fee for December is currently \$2,600.00.
- 2. Deposits totaling \$2,940.00 have been made with the treasurer's office for November with \$2,020.00 for work release and \$920.00 for weekend fees.
- 3. The November assessed revenue report generated from the Greene County Central Booking Center is \$5,950.00.
