MOTIONS

SECURITY

- 1. There were four (4) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of October 2020.
- 2. The facility issued ten (10) major misconducts and twenty-two (22) minor misconducts for the month of October 2020.

TREATMENT

1. For the month of November, we have currently conducted two (2) Bible Classes with Landmark Baptist Church and one (1) day of Haircuts.

STAFFING AND TRAINING

1. Officer's Hixenbaugh, Six, and Roberts will be attending the PA DOC Training Academy on December 3rd for a condensed schedule of twelve (12) hour days including weekends.

MAINTENANCE

- 1. The Men's Work Crew is down to one (1) member at this time and they are currently tasked with constructing tamper proof ceil vent covers in our efforts to maintain air restriction within the facility.
- 2. Huckestein Mechanical has completed the replacement of the secondary air handler system.

FINANCIAL REPORT

- 1. The October assessed revenue report generated from the Greene County Central Booking Center was \$7,350.00 with \$1,572.84 being an actual paid return for the month.
- 2. We have deposited \$960.00 for Work Release Inmates and \$760.00 for Weekend sentenced Inmates totaling \$1,720.00 for October 2020.
- 3. Fayette County paid \$1,550.00 in rental fees for the month of October, and currently owes \$950.00 for November 2020.
- 4. The total revenue received for October was \$ 4,842.84
