GREENE COUNTY CONSERVATION DISTRICT REGULAR MEETING MINUTES February 19, 2021

Organizational Sign-On Letter: Support Expansion of the Proposed PA Science Standards Ms. Snider noted the state is changing the education requirements by removing the Environmental Education section of a school's curriculum.

A motion was made by Dave Shipman to approve opposing the removal of Environmental Education from school curriculum. Commissioner Belding seconded. (Motion Passed)

2021 Budget Adjustments

Ms. Snider received the supplemental state approved information with the additional approved budget totaling \$198,268.00. Lisa included three spreadsheets in the meeting packet. One showing a breakdown of programs the new funding would be used in via employee salary and benefits. Second spreadsheet was the original 2021 budget that was approved. The third spreadsheet is an updated version of the budget with the new approved state funding along with West Nile Virus updated funding.

A motion was made by Commissioner Belding to approve budget adjustments. Greg Hopkins seconded. (Motion Passed)

DGLVR Application Engineering Fee Schedule

Ms. Snider, Ms. Kozlowski and Ms. Hlatky had administrative training for Dirt and Gravel Roads Program. During this training Ms. Snider asked if paying for an engineer via a fee schedule is an allowable expense. State Conservation Commission (SCC) stated this is an allowable expense. Ms. Snider suggested the board look into the possibility of hiring an engineer on a project-by-project basis to assist with the development of complex applications for townships. Once the projects are approved the township can utilize the same engineer to help with the development of bid packages, permit documents and site development. The idea is to have a better understanding of the costs associated with a project upfront. Lisa asked the board to think over the idea of hiring an engineer for assistance with larger projects.
