#### **TREATMENT**

1. On 05-15-19 the Centerville Clinics, Inc. sent a supervisor for blended case managers (BCM) to meet with an inmate for the purpose of assigning a BCM in preparation to return to the community. The BCM will assist the inmate in securing services that will include drug and alcohol, mental health, medical, and the re-instatement of social security/medical access card.

- 3. The May assessed revenue report generated from the Greene County Central Booking Center was \$7,825.00 with a collected amount of \$1,678.99 being paid to the Greene County Clerk of Courts office. The current year to date through May on assessed fee's is \$36,700.00.
