### **MOTIONS**

#### **SECURITY**

- 1. No reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the month of July 2019.

#### **TREATMENT**

1. Mental Health Director Brean Fuller has established mental health assessment services with AXIOM Family Counseling to provide on-site assessments. This service eliminates the previous requirement to take inmates off grounds to an outside provider. Director Fuller will be soliciting the possibility of utilizing AXIOM for additional mental health services should they have staff available for our specific needs and based on her development of this potential resource we will submit a proposal for county review.

1. Officers Nathan Traux and Zachery Phillips graduated for the PA DOC training academy last week. Officer Maria Barone and food service worker Andrea Orlandi are scheduled to attend the academy later this month.

#### **MAINTENANCE**

1. Mr. Ziefel and his worker completed daily trash detail and tent erection for the County Fair along with a limited number of facility and county assignments.

#### **FINANCIAL REPORT**

- 1. Fayette County owes \$600.00 for the month of July and owes nothing for the month of August.
- 2. Deposits totaling \$4,400.00 have been made with the Treasurer's office for July with \$3,200.00 for work release and \$1,200.00 for weekend fees.
- 3. The July assessed revenue report generated from the Greene County Central Booking Center was \$10,150.00 with a collected total of \$1,340.59 paid to the Clerk of Courts.
