August 18, 2022

The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the County Building in the 1st floor conference room. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Chief Clerk Jeff Marshall, Deputy Warden Jerad Cline, Controller Cree, Solicitor Grimm and Megan Phillips. The Minutes from 3- 17-22 were motioned for approval by Commissioner McClure and 2nd by Commissioner Zimmerman. The vote was unanimous for approval of the minutes. Adjournment was motioned by Commissioner McClure and 2nd by Commissioner Zimmerman. The vote to adjourn was unanimous.

#### **SECURITY**

- 1. There were seven (7) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of July 2022
- 2. The facility issued Sixteen (16) major misconducts and Fourteen (14) minor misconducts for the month of July 2022.
- 3. The average daily population for July was Sixty-Three (63) with Fifty-Eight (58) being the lowest number and Seventy-Two (72) being the highest

#### **TREATMENT**

1. During the month of July, Landmark Baptist Church conducted Three (3) men's bible study groups.

- Celebrate Recovery conducted Four (4) men's bible study groups. First Assembly Church conducted Four (4) women's bible study groups.
- 2. During the month of July, the facility hosted Seven (7) Narcotics Anonymous meetings, Four (4) SAFE Parenting groups.
