### SECURITY

1. There were Three (3) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of January 2024
2. The facility issued Eighteen (18) major misconducts and Eighteen (18) minor misconducts for the month of January, 2024.
3. The average daily population for January, was Fifty-Eight (58) with Fifty-Three (53) being the lowest number and Sixty-Two (62) being the highest
