# COMMISSIONERS MEETING DECEMBER 19, 2019

The Greene County Commissioners meeting was brought to order by Chairman Blair Zimmerman at 10:00 am in the first-floor meeting room of the County office building. Others in attendance were: Commissioner Coder, Commissioner Trader, Cheryl Cowen, Steve Barrett, Cara Cox, Becky Harris, Marcy Maletta, Scott Kelley, Lu Lewis, Amy Cree, Carol Gooden, Charlotte Popielarcheck, Members of the Press and the General Public.

MINUTES— Commissioner Trader made the motion and Commissioner Coder the second to approve the minutes from the previous meeting. Vote unanimous.

#### BRIDGES

- 1. Commissioner Coder made the motion and Commissioner Trader the second to approve a time extension until December 31, 2020 to complete the preliminary design for County Bridge #15. Vote unanimous.
- 2. Commissioner Trader made the motion and Commissioner Coder the second to approve a time extension until June 9, 2020 for the right-of-way phase for County Bridge #63. Vote unanimous.

### FINANCE AND ADMINISTRATION

- 1. Commissioner Coder made the motion and Commissioner Trader the second to approve the meeting dates and times for the commissioners' agenda and regular meetings, along with salary, retirement, prison, assessment, sinking fund, election board meetings and advise the Chief Clerk to advertise. Vote unanimous.
- 2. Commissioner Trader made the motion and Commissioner Coder the second to resolve to adopt the budgets for the County of Greene 2020 general fund, liquid fuels fund, 911 fund, tourism fund, and domestic relations fund. It should be noted that the Act 13 allocation received in July of 2019 is also listed on the cover sheet of the 2020 budget. Vote unanimous.
- 3. Commissioner Coder made the motion and Commissioner Trader the second to incorporate the human services, MH/IDD/D&A, transportation, and children & youth services fiscal year budgets, which were granted/adopted at the beginning of the state fiscal year July 1, 2019, into the 2020 unified budget. Vote unanimous.
- 4. Commissioner Trader made the motion and Commissioner Coder the second to set the millage for property taxes within the County of Greene for the year 2020 at the following rates: Vote unanimous.

- a. General Fund -6.77 mills or 67.7 cents on each one hundred dollars of assessed valuation
- b. Debt Services .695 mills or 6.95 cents on each one hundred dollars of assessed valuation
- c. Library Fund .07 mills or .7 cents on each one hundred dollars of assessed valuation
- 5. Commissioner Coder made the motion and Commissioner Trader the second to approve an allocation of Act 13 funds received in 2019 and incorporate in the budget. Vote unanimous.
- 6. Commissioner Trader made the motion and Commissioner Zimmerman the second with Commissioner Coder abstaining to approve an agreement between the County of Greene and the CARE Center for services at the Greene County Jail commencing on January 1, 2020 and ending on December 31, 2021. Vote unanimous.
- 7. Commissioner Coder made the motion and Commissioner Trader the second to approve a notice of lease termination from Representative Pam Snyder as of December 31, 2019. Vote unanimous.
- 8. Commissioner Trader made the motion and Commissioner Coder the second to approve support letters to the Pennsylvania Department of Community and Economic Development for the Jacobs Ferry Road Waterline Extension Project. Vote unanimous.
- 9. Commissioner Coder made the motion and Commissioner Trader the second to approve a resolution authorizing the submission of a PA Small Water and Sewer Program Application for Jacobs Ferry Road Water Line Extension Project to the Pennsylvania Department of Community and Economic Development. Vote unanimous.
- 10. Commissioner Trader made the motion and Commissioner Coder the second to approve the Carmichaels Area Historical Society tax forgiveness on property 305 North Market Street as it pertains to the Carmichaels School District. Vote unanimous.
- 11. Commissioner Coder made the motion and Commissioner Trader the second to approve the 2020 faithful performance of duty coverage insurance binder to satisfy criteria set for Act 106 of 2011 and approve the form and amount of the required security. Vote unanimous.
- 12. Commissioner Trader made the motion and Commissioner Coder the second to approve an agreement between the County of Greene and Tropical Amusements, Inc. for amusement service at the Greene County Fair. Vote unanimous.
- 13. Commissioner Coder made the motion and Commissioner Trader the second to approve a service agreement between the County of Greene and

- Advanced Communications Company for telephone equipment at the Greene County Courthouse for the period of 01-30-20 to 01-30-2021 in the amount of \$502.00. Vote unanimous.
- 14. Commissioner Trader made the motion and Commissioner Coder the second to approve the Savin Maintenance and Service Agreement between the County of Greene and the Pennsylvania District Attorneys Institute for a period of 01-01-20 through 12-31-2020. Vote unanimous.
