- 2. Don Chappel made the motion and Casey Durdines seconded to approve the June 8, 2022 meeting minutes. Vote was unanimous.

1. Courtney Hursey made the motion and Casey Durdines seconded to approve the July 13, 2022 Disbursement Request (Attachment 1) totaling \$14,790.54. Vote was unanimous.

1. The Domestic Violence Services of Southwestern PA is holding a walking history tour of Waynesburg on Wednesday, July 27, 2022 at 6:30pm. The Fort Jackson Building and Tourism will be one of the stops. The event is free and board members are welcome to attend.

#### COMMITTEE REPORTS

#### Finance

- Don Chappel made the motion and Courtney Hursey seconded to use Stamps.com for postage services. The monthly fee is \$17.99 with the first three months free. Vote passed with Casey Durdines opposed.
- 2. JoAnne Marshall reported that due to the increase usage of the credit card with digital marketing and postage, she requested for a raise in the card's limit. It was raised to \$3,500.

#### Advertising

- 1. Liz Menhart made the motion and Dan Bazzoli seconded to approve the video production proposal of \$1,250 by Sparks Productions for the VisitPA co-op program. Vote was unanimous.
- 2. Courtney Hursey made the motion and Dan Bazzoli seconded to acquire the Gold Package for \$8,662.50 plus the Custom Content Article Renewal for \$1,995 and three additional E-newsletters ads for \$2,550 if grant funding is still available from the state. If grant funding is unavailable, the purchase will be for the Silver Package and add-ons below. Vote was unanimous.
  - a. The Silver Package is \$5,337.50 with the Custom Content Article Renewal for \$1,995, three additional E-newsletters ads for \$2,550, and one quarter of Online Leads for \$2,000.
- 3. Don Chappel made the motion and Dan Bazzoli seconded to purchase a full-page ad for \$250 in the Greene County Chamber of Commerce's 2022-23 Member Directory and a full-page ad for

\$150 in the King Coal Association's program book. Vote passed with Deneen Rhodes and Casey Durdines abstaining.

4. Courtney Hursey made the motion and Casey Durdines seconded to purchase a \$3,950 twospread package from Travel Taste + Tour. Vote was unanimous.

#### Fundraising

1. JoAnne Marshall shared that progress on the digital pass and #DineGreene21 was postponed due to time constraints. #DineGreene21 will be launched for a fall timeline. The digital pass will be reimagined to work directly with Waynesburg University students. Discussion was held on various prize possibilities to encourage participation on the pass.

#### Hotel/Motel Tax

1. Hotel occupancy for May 2022 was 55.0%, average daily room rate was \$87.12, the revenue per available room was \$47.95, and the number of rooms sold were 6,484.
