**MINUTES OF MORGAN TOWNSHIP  
February 6, 2024**

**CALL TO ORDER:** At 4:00 p.m. Jeff Sholtis, Chairman, called the regular monthly meeting of the Morgan Township Supervisors to order in the municipal office building located at 1019 Third Street Extension, Mather, Greene County, Pennsylvania. The meeting opened with the pledge to the flag.

**ROLL CALL:** Supervisors Jeff Sholtis, Erik Mullen and Shirl Barnhart (called in by phone) were present. Also attending the meeting was Stacy Sholtis, George Scull, Steve Lee, Susan Nelson, Fay Palmer, Code Enforcement Officer Mark Gordon, Solicitor Dennis Makel and Secretary/Treasurer Relda Litten.

**APPROVE MINUTES:** A motion was made by Mr. Sholtis with a second from Mr. Mullen to approve the minutes of the January 2, 2024 meeting and the motion carried with all in favor.

**PUBLIC COMMENTS:** Mr. Scull asked if the township is going to be paving the roads this year. Mr. Sholtis has been compiling a list of roads needing done.

**REPORTS:** Roadmaster: Supervisors reported they have done snow removal two times in early January, completed vehicle maintenance and inspections, cut trees, cold patched, reset signs and replaced some, cleaned culverts and ditches, and commended Stacy Sholtis for cleaning up Reservoir Hill Road and the road coming in to Mather.

**CODE ENFORCEMENT OFFICER:** Mr. Gordon stated he will send the owner of 518 in Mather another notice as another complaint has come into about the house and yard. Mr. Gordon made the comment that he has never signed off on that site.
