

2020 Greene County Recreational Development Grant

The youth of Greene County are the future of Greene County. Like all youth, they are subject to various influences that could entice them to go down the proverbial "wrong path". It is paramount that we, as parents, grandparents, and leaders within the community, provide the children with an opportunity to select the right path. As elected officials we can assist in this process by providing the youth of today with facilities that can provide activities, to hopefully improve their chances of selecting a path that will be of the most benefit to them.

By creating a funding source for municipalities located within Greene County, we hope to initiate the process for the construction of additional recreational facilities or the enhancement of existing recreational facilities throughout Greene County.

Criteria for any municipalities that wish to make application for the grant will be as follows:

- 1. The municipality must be located in Greene County.
- 2. The application must be received by the County by March 1, 2020.
- 3. The municipality that is applying for the grant must own or possess a long-term lease for the property.
- 4. The monies cannot be used for land acquisition.
- 5. Requested amount cannot exceed \$3,000.
- 6. Use of the monies can only be for the construction of a new facility and/or the enhancement of an existing facility located in Greene County.
- 7. Priority will be given to the construction of a new facility.
- 8. The monies cannot be designated for routine maintenance of an existing facility.
- 9. The monies must be matched by the requesting organization.
- 10. The match may be either monetary or approved in-kind services.
- 11. The match determination must be outlined in the application.
- 12. Priority will be given to projects designated for the youth of Greene County.
- 13. Priority will be given to municipalities that did not receive a grant the previous year.
- 14. Time limit: Project must be completed within 1 year of approval. All monies not spent in the allotted time are to be returned to the County.
- 15. Audit: An internal audit, inclusive of all of the required documentation of the monetary match and all approved in-kind services will be conducted throughout the life of the project.
- 16. Any previous or forthcoming designs shall be shared with all additional projects.
- 17. Photos of completed project will need to be submitted with paid invoices.
- 18. A Narrative will need to accompany paperwork to outline all work completed.

This is a reimbursement program. Payment will be made upon presentation of Paid invoices.

Areas to be addressed in the grant application will be the delineation of the coordinating entity for the facility, the justification of an additional facility for that region and the minimization of any duplication within the process. The best interest of the youth of Greene County must be the primary concern of the potential recreational grant recipient.
