1. Received Correspondence:

- On July 16, the township received a letter from Adam Mattis, the Regional Advisor for the Southwest Regional Office of the Department of Conservation and Natural Resources congratulating the Supervisors for the accomplishments obtained through the improvements to the park, specifically the renovated comfort station, the ADA accessible pathways and for bringing reliable public water to the facility. He also inspected the project to verify that it was completed in accordance with the approved Scope of Work and Grant Agreement and was found to be in compliance.
- The township's Act 537 Sewage Facilities Planning Special Study has been submitted to the DEP for final approval.
- We have been advised by Mackin Engineering that Jenni Easton, who was very instrumental in completing the township's Comprehensive Plan and the updating of the Zoning ordinance and SALDO, has resigned from the firm to pursue other opportunities. Brandi Rosselli will be assisting us with the completion of those revised ordinances.

2. Planning Board: The Board did not meet in August due to the lack of any items needing attention or action; however, comments were solicited from the Planning Board members regarding a matter to come before the Zoning Hearing Board.

3. Zoning Board: It is anticipated that the Zoning Hearing Board will meet on August 27 to hear a Request for a Variance regarding a side-yard setback. Due to COVID-19 concerns, plans are being made to conduct the hearing virtually via a Zoom meeting.

c. 2020-21 Impact Fund Budget

As announced at the July meeting, the township received \$549,400 from the PA Act 13 Impact Fee fund. As required, attached is the township's spending plan for the funds.

d. Purchase of CAT 259D3 Compact Track Loader

Recommended Action

Pursuant to action taken at the July 14, 2020 meeting, specifications were prepared and requests for quotations were obtained from several companies that participate in cooperative purchasing programs (i.e. COSTARS) for a new Compact Track Loader equal to or better than a Caterpillar 259D3, with a loader bucket, angle broom and pallet forks. Murphy's bid did not include the pallet forks. The quotes received are as follows:

Following review of all of the bidding information received, consider a motion to purchase the "as specified" Caterpillar 259D3 Compact Track Loader, with a loader bucket, angle broom and pallet forks from Cleveland Brothers under State contract #4400019950, at the submitted bid price of \$61,000. While Bobcat's bid was slightly lower, it is for a new model yet unavailable, with no anticipated delivery date given. The CAT can be delivered immediately upon payment.

3. Operations, Buildings, Grounds & Highways

a. Craynes Run Road Flex-base Paving Project Bid Opening & Award

Recommended Action

Pursuant to the prepared and advertised specifications, bids were received and opened at 11:00 am, Monday, August 10, 2020 for the labor, material, and equipment necessary to complete flex-base paving on Craynes Run Road between Rt. 221 and the intersection

with Wilman Hill, an approximate distance of 12,170 feet. One bid (w/Bid Bond) was received for the project.

Having met the specifications, consider a motion to award the contract for the placement of approximately 1,735 (+/-) tons of flex-base paving on Craynes Run Road between Rt. 221 and Wilman Hill, to Russell Standard Corporation, at their low bid of \$89.25 per ton for a total cost of \$154,848.75. Cost of the project to be paid from the Impact Fee Fund.

2. Adoption of Ordinance Number 1 of 2020 to Update and Amend the Township's Non-Uniform Pension Plan

Recommended Action

Consider a motion to adopt the following Ordinance (#1-2020):

AN ORDINANCE OF WASHINGTON TOWNSHIP, GREENE COUNTY, COMMONWEALTH OF PENNSYLVANIA, ELECTING TO AMEND ITS NON-UNIFORM PENSION PLAN ADMINISTERED BY THE PENNSYLVANIA MUNICIPAL RETIREMENT SYSTEM PURSUANT TO ARTICLE IV OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW; AGREEING TO BE BOUND BY ALL PROVISIONS OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW AS AMENDED AND AS APPLICABLE TO MEMBER MUNICIPALITIES. IT IS HEREBY ORDAINED BY WASHINGTON TOWNSHIP, GREENE COUNTY, AS FOLLOWS:

SECTION I. Washington Township (the Township), having established a non-uniform pension plan administered by the Pennsylvania Municipal Retirement System (the System), hereby elects to amend its Non-Uniform Pension Plan administered by the System in accordance with Article IV of the Pennsylvania Municipal Retirement Law, 53 P.S. §881.101 et seq. (Retirement Law), and

does hereby agree to be bound by all the requirements and provisions of the Retirement Law and the Municipal Pension Plan Funding Standard and Recovery Act, 53 P.S. §895.101 et seq., and to assume all obligations, financial and otherwise, placed upon member municipalities.

SECTION II. As part of this Ordinance, the Township agrees that the System shall administer and provide the benefits set forth in the amended Non-Uniform Pension Plan Document entered into between the Pennsylvania Municipal Retirement Board and the Township effective as of the date specified in the adoption agreement (the Contract).

SECTION III. The Township acknowledges that by passage and adoption of this Ordinance, the Township officially accepts the Contract and the financial obligations resulting from the administration of the Contract.

SECTION IV. Payment for any obligation established by the adoption of this Ordinance and the Contract shall be made by the Township in accordance with the Retirement Law and the Municipal Pension Plan Funding Standard and Recovery Act. The Township hereby assumes all liability for any unfundedness created due to the benefit structure set forth in the Contract.

SECTION V. The Township intends this Ordinance to be the complete authorization of the Contract, as amended and it shall become effective as of the date specified in the adoption agreement, which is the effective date of the Contract, as amended.

SECTION VI. A duly certified copy of this Ordinance and an executed Contract shall be filed with the System.
