

Perry Township Board of Supervisors
August 11, 2020
3:00 P.M.

Call to order by Facilitator: Frank Basile, Chairman, with board members present: Ronald Howard and Mickey Lemley with Chris Jarrell, Secretary, and Solicitor Dennis Makel.

Pledge to Flag.

Bid Opening: Fuel bids were opened. A motion was made by Mickey Lemley seconded by Ron Howard to award the fuel bid to Bruceton Petroleum with the low bid of \$1.18/gasoline and \$1.23/diesel. Flex Base – one bid received from Russell Standard Corp. A motion was made by Mickey Lemley seconded by Ron Howard to award the road bid to Russell Standard at a price of \$16.50/sq yard (3350 yards total) totaling \$55,275.00. Bids for Pick up and International truck were opened. A motion was made by Mickey Lemley seconded by Ron Howard to sell the International Dump truck to the high bidder, Charles Lemley, at the sale price of \$5658.28. A motion was made by Ron Howard seconded by Mickey Lemley to sell the GMC Pick-up truck to the high bidder, Mike Venziano, at the sale price of \$2007.00. Motions passed.

Public in Attendance: None due to Covid 19.

Public Comments: (all comments are limited to no more than 5 minutes per person). An email was read from John Frazier regarding the “No Outlet” sign at the corner of Washington and Floral. A motion was made by Mickey Lemley seconded by Ron Howard to leave the current sign but add new signs to the corner of Jefferson: No Outlet and Children at Play. Motion passed.

An email was received from Dreama Frazier which will be replied to. Mrs. Frazier inquired about the Township Facebook page. It has been changed to public and the Township is in the process of purchasing a Domain name for the webpage. Mrs. Frazier asked about the webpage being more “user friendly” which the Domain name will direct you straight to the Perry Township page. The County failed to post the July Minutes but the Township secretary took a training class today and is learning to post all the information from our office. Question 4 inquired why someone from the Township contacted the company planning to paint the lines at the basketball court? Financial protocol dictates the bill be in the Township name and the Township will utilize the Vendor for another job to save money. Question 5 asked about cameras for the basketball court and they are currently being investigated.

Old Business: The Emergency Declaration for Covid 19 has been extended through December 31, 2020. Cases are on the rise in Greene County again. New Declaration was signed on Thursday, July 30, 2020.

New Business:

A motion is needed to approve the purchase of a Domain name. Greene County provides a website for each Municipality and it would be in the Township’s best interest to have one location to provide public information. The Domain name cost per year is approximately \$36.98. Motion by Ron Howard seconded by Mickey Lemley. Motion approved.

The Recreation Board has requested an additional \$1,000 for the Back to School event. Said money will be used as requested: \$500 for additional notebooks, \$150 socks, \$200 shampoo/body wash, \$150 for scissors and monies already spent on receipts turned in. The Rec Board would like to authority to reallocate funds if they need to purchase an item. Motion by Ron Howard seconded by Frank Basile that the additional \$1000 be approved with the stipulations that the money be used for notebooks, pens, pencils, erasers, scissors, paper and hand sanitizer. The purchase must be made through the Township office. Someone from the Rec Board needs to come to the office to order or send the order to the Township secretary and she will place the order. This saves money as the Township is Tax Exempt. Motion approved.

A motion is needed to approve the minutes of board meeting July 14, 2020. Motion by Mickey Lemley seconded by Ron Howard. VOTE: All in favor.

Treasurers Report: A motion is needed to approve the Treasurer's Report and pay bills. General Fund & Special Funds: \$20,985.47. Payroll funds: \$21,641.10. Motion by Ron Howard seconded by Mickey Lemley. Vote: All in favor.

A motion to adjourn at 3:28 pm was made by Ron Howard seconded by Mickey Lemley. Motion approved.
