Recommended Action

Afternoon day (11am - 5pm)	60.00
Evening (6pm – 9pm)	30.00

4. Payment of Medicare and Supplemental Insurance Premiums

In that the township Secretary and her spouse will both be covered by Medicare during 2019, she has requested the Supervisors consider paying for their Medicare and Supplemental Insurance premiums in lieu of paying their respective premiums for coverage under the township's UPMC health insurance plan, to which they are entitled by her employment agreement. This would result in a savings to the township of nearly \$4,700 during 2019.

Recommended Action

Consider a motion to approve the payment by the township for the Medicare and Supplemental Insurance premiums for the Township Secretary and her spouse, in lieu of paying their health insurance premiums charged by the township's health insurance program (UPMC) for which they would be entitled, resulting in a savings to the township of \$4,686.
