

Greene County Farmland Preservation Minutes <u>March 21st, 2018 at 7:00 p.m.</u> Greene County Conservation District Conference Room Waynesburg, PA

CALL TO ORDER AND INTRODUCTION OF GUESTS

As stated at the last meeting as well, the Cree's farm has been paid for and recorded. GCFLP is waiting for the final incidental costs check of \$837.35. Ms. Wright had to send additional paperwork the beginning of February and is expecting the check to be sent soon.

David K. Bell #1 (87.78 acres) - LESA Score: 38.81

This easement was closed and recorded on March 14th, 2018. Ms. Wright will be sending in a letter for additional incidental costs before the next meeting for this property as well. The amount should be similar to the Cree farm request.

Ms. Wright stated that the Board received a letter from Barbetta's that they are intending to obtain ownership of their surface coal rights. The letter also stated that they were ready to begin the advertising portion of the quiet title process.

Bylaw Modification to be submitted to PA Department of Agriculture for Approval

Ms. Wright stated the following changes were made to the GCFLP Bylaws per request of the Board: On page 15 after the bullet - "Name or names of the owners of the mineral rights." The following was added — "Once an application and fee is received by staff the Farmland Preservation Board Solicitor will conduct a preliminary review of surface coal ownership. If the solicitor deems that the surface coal rights are retained by the applicant then an application can be accepted for ranking. If the coal rights are not retained that application is responsible to obtain the ownership to obtain the ownership prior to continuing the application process." Additionally, the names and term dates of the Board members were updated.

Ms. Snider mentioned that the annual report was completed and should be sent out soon. Also, that there would be newsletter coming out in April.
