

# Greene County Farmland Preservation Minutes October 11<sup>th</sup>, 2017 at 12:30 p.m. Lavern's Restaurant Jefferson, PA

## **Additional Public Notices for FLP Application Period**

At the April 19<sup>th</sup>, 2017 FLP meeting, the board voted to advertise the application period on the radio and in the newspaper. As a result, two applications were received, a few days after it aired on the radio in June. The board was asked to consider if additional advertisements should be done.

Following a brief discussion, a motion was made by Charlie Day to re-advertise the application period on the radio. Corbly Orndorff seconded. (Motion Passed)

## **FLP Application Update**

Since problems occurred regarding the percentage of agricultural use for the Bell easement, the staff felt there was a need to revise the FLP easement application. Step 4 was added in ensure that the property qualifies; with at least 50% of the land being used as agriculture.

Following discussion, a motion was made by Corbly Orndorff to approve this change to the easement application. Chris Eisiminger seconded. (Motion Passed)

## Ruff Creek Area Act 357 Plan, Washington Township - Request for Comments

A request was received from the Eads Group to determine if the planned sewage work, in the area, would affect preserved farms. Ms. Wright has drafted a letter and maps to show the agricultural security areas as well as possible FLP growth areas.

Following a brief discussion, a motion was made by Rick Thistlethwaite to send the letter stating that the project should not impact any agricultural easements. Jim Willis seconded. (Motion Passed)

## **Greene County Conservation District (GCCD) – Nominations**

As a nominating organization, a request for nominations for GCCD directors was received from the Greene County Commissioners office. The terms of Tom Headlee and Greg Hopkins, both who are willing to continue their service, will expire on December 31, 2017.

Following a brief discussion, a motion was made by Jim Willis to nominate Tom Headlee and Greg Hopkins. Chris Eisiminger seconded. (Motion Passed)

## 2017 Inspections Approval - Harry Farm

An inspection of the farm was done prior to this meeting and found no changes to the property and no violations.

A motion was made by Rick Thistlethwaite to send the compliance letter to the PA Bureau of Farmland Preservation. Charlie Day seconded. (Motion Passed)

## **Board Member Renewals**

The terms of William Cree, III, Richard Belding and James Willis will expire at the end of the year and they will need to be reappointed by the Greene County Commissioners.

A motion was made by Dave Shipman to send a letter to the commissioners requesting the reappointment of these directors. Chris Eisiminger seconded. (Motion Passed)

## **Chairman Appointment**

The position of chairman is appointed annually by the Greene County Commissioners.

A motion was made by Dave Shipman to send a letter to the Greene County Commissioners requesting the reappointment of William Cree, III as chairman. Charlie Day seconded. (Motion Passed)

## 2016 GCFLP Agricultural Easements

William A. Cree, Jr. and Lura Ann Cree #2 (57.35 acres) – LESA Score: 43.37

The Cree's have accepted the offer. The closing date will be slightly delayed, as two checks were issued by the state; one to Mr. Cree and one to Mrs. Cree. Since the deed shows only Mr. Cree as the property owner, the checks were returned to the state and a new check must be issued. The closing will be scheduled once the new check is received.

David K. Bell #1 (87.78 acres) - LESA Score: 38.81

Mr. Bell has the accepted offer. This easement is scheduled to be discussed at the PA Bureau of Farmland Preservation board meeting on October 12, 2017.

#### **OUTREACH**

Mr. Bradley Eisiminger has applied for an Agricultural Security Area (ASA) in Whiteley Township. Another property owner may join him in this application. His farm alone, should meet the acreage requirements.

## **STAFF REPORTS**

Ms. Snider noted that the Greene County Conservation District is processing applications for lime and fertilizer application, water systems, fencing, etc. under the Greene County's Reinvestment in Agriculture: Conservation Enhancement (GRACE) program. The program is being funded with unconventional gas well fund and GCCD funds.
