MINUTES— Commissioner Trader made the motion and Commissioner Coder the second to approve the minutes from July 19, 2018. Vote unanimous.

FINANCE AND ADMINISTRATION

- 1. Commissioner Coder made the motion and Commissioner Trader the second to approve an ordinance authorizing nonelectoral debt/loan agreement in the presently estimated maximum amount of \$1,120,000 with the Pennsylvania Infrastructure Bank at a rate of 2.375%. Vote unanimous.
