The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the first-floor meeting room of the County office building. MOTIONS

Commissioner Betsy McClure made the motion and Carol Gooden the second to approve the minutes from the September 17th 2020 Prison Board meeting. Vote unanimous.

SECURITY

1. There were six (6) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of September 2020.

2. The facility issued seven (7) major misconducts and seven (7) minor misconducts for the month of September 2020.

TREATMENT

1 As of 10-26-20, we conducted Inmate haircuts twice, had one session of Bible Study from the Waynesburg Bible Chapel, and three Bible Study groups by the Landmark Baptist Church.

2. On 10-22-20, we conducted a discussion and development session with Doctor Porbin, Director Fox from Drug and Alcohol, Director Fuller from Mental Health, Counselor Virgili, and myself regarding Doctor Porbin's proposed Opiate Detox Protocol.

STAFFING AND TRAINING

1. On 10-14-20 and 10-28-20 Substance Abuse Disorder Training was conducted via ZOOM through a Power-point presentation by Pitt PERU allowing staff to interact with the instruction.

2. On 10-21-20, Right to Know Training was conducted at the National Guard Armory and presented by Mr. Brad Langerman from Steratore.

MAINTENANCE

1. The Men's Work Crew continues to perform limited functions within the County.

FINANCIAL REPORT

1. The September assessed revenue report generated from the Greene County Central Booking Center was \$7,350.00 with \$1,794.42 being an actual paid return for the month.

2. We have deposited \$ 1,140.00 for Work Release Inmates and \$1,160.00 for Weekend sentenced Inmates totaling \$2,300.00 for September 2020.

3. Fayette County has paid \$2,350.00 in trental fees for the month of September, and currently owes \$1,300.00 for October 2020.

4. The total revenue received for September was \$ 6,444.42
