PROCLAMATIONS

1. Commissioner Coder made the motion and Commissioner Trader the second for a proclamation for October 2017 as Domestic Violence Awareness Month. Vote unanimous.

Texas Eastern Transmission, LP has submitted a general permit BWEW GP-8 and BWEW GP-11 registration and supporting information to the Pennsylvania Department of Environmental Protection Southwest Regional Office for maintenance of Texas Eastern's existing line 10 pipeline system at mileposts Richhill and Center Townships.

Duquesne Light Company is filing an application with the Pennsylvania Department of Environmental Protection for a chapter 105 water obstruction and encroachment general permit and a general permit 11 maintenance testing, repair, rehabilitation or replacement of water obstructions and encroachments located in Monongahela Township.
