MINUTES: Commissioner Betsy McClure made the motion and Controller Ami Cree the second to approve the minutes from the October 29, 2020 meeting. Vote unanimous.

ASSESSMENT

1. Commissioner Betsy McClure made the motion and Controller Ami Cree the second to approve the retirement of Melody Lesko, regular full time Administrative Assistant II, effective November 3, 2020. Pay all applicable leave balances including sick time at \$50/day and \$5,000 severance. Vote unanimous.
