 - 1. Received Correspondence:
 - Received the 2021 Certified Summary Tax Assessment roll from the County Assessment Office showing a total taxable assessment of \$50,030,088 in the township. This is a major decrease of \$3,166,637 in tax assessment from 2020 due mainly to the depletion of coal owned and actively mined by Consol, PA. The change equates to a decrease in tax revenue of approximately \$7,600.
 - The Impact Fee Fund Certificate of Deposit in the amount of \$1,200,000.00 matured on November 26, 2020, returning earned interest of \$23,582.25. Requests for quotes for a 12-month renewal of the principal amount were obtained from First National Bank and Community Bank resulting in bids of .25% and .20% respectively. We also examined the PA Municipal bond market to determine if there were any Act 10 allowable investment instruments available that would pay a higher rate of interest, but unfortunately, found none. Since the Impact Fee Money Market Fund at First National is currently paying .35%, the funds will be left in that account until such time as bond market conditions change or CD rates increase
 - 2. Planning Board:

There were no items for discussion or needing action so the December 3rd meeting was cancelled. The Planning Board members were provided with the listing of various permits issued during 2020 by the township. That list is attached to the agenda.
