MINUTES

Walter Stout, Chairman, called the meeting to order at 7:00 PM.

In attendance were Supervisors Walter Stout, Charles Hickman and Troy Smith, Secretary Diane Headlee and township resident Jason Rosa.

I. Requests to Address the Board/Public Comment

No requests or public comments.

- II. Correspondence and Reports
 - 1. Received Correspondence:

• Received the 2021 Certified Summary Tax Assessment roll from the County Assessment Office showing a total taxable assessment of \$50,030,088 in the township. This is a major decrease of \$3,166,637 in tax assessment from 2020 due mainly to the depletion of coal owned and actively mined by Consol, PA. The change equates to a decrease in tax revenue of approximately \$7,600.

• The Impact Fee Fund Certificate of Deposit in the amount of \$1,200,000.00 matured on November 26, 2020, returning earned interest of \$23,582.25. Requests for quotes for a 12-month renewal of the principal amount were obtained from First National Bank and Community Bank resulting in bids of .25% and .20% respectively. We also examined the PA Municipal bond market to determine if there were any Act 10 allowable investment instruments available that would pay a higher rate of interest, but unfortunately, found none. Since the Impact Fee Money Market Fund at First National is currently paying .35%, the funds will be left in that account until such time as bond market conditions change or CD rates increase

2. Planning Board:

There were no items for discussion or needing action so the December 3rd meeting was cancelled. The Planning Board members were provided with the listing of various permits issued during 2020 by the township.

3. Zoning Hearing Board:

There was no action needed by the Zoning Hearing Board in November. As such, there was no meeting.

4. Park Board:

There was no meeting in November.

- 5. Roadmaster's Report:
 - Construction of the Garner Road waterline is continuing, with no known issues. The road crew worked on winter road maintenance, mowed road banks, readied equipment in preparation for winter road maintenance, and removing trees and limbs from township roads following recent wind storms. The road crew also

assisted Hayden Excavation with work on the culvert pipe replacement project on Greene Valley.

6. Solicitor's Remarks: Not in attendance, however, the solicitor's office has been dealing with COVID.

a. <u>Heavy Hauling Agreements – Donald Livengood</u>

The Chairman asked the Board to consider a motion to approve Heavy Hauling Agreements dated November 2, 2020, along with subsequent bonds with Donald Livengood for Craig's Run Road (T-558), and for Fisher Hollow Road (T-559), for a fee of \$300.00 per roadway, pursuant to the approved Schedule of Fees, pending payment and receipt of the fees. The motion was made by Charles Hickman and seconded by Troy Smith. Motion carried.

b. <u>Heavy Hauling Agreement – Y-B Logging-Lumber Co.</u>

The Chairman asked the Board to consider a motion to approve a Heavy Hauling Agreement dated December 8, 2020, along with subsequent bond with Y-B Logging-Lumber Co. for Hemlock Road (T-401), for a fee of \$300.00, pursuant to the approved Schedule of Fees. The motion was made by Charles Hickman and seconded by Troy Smith. Motion carried.

3. <u>Township Supervisors</u>

a. Adoption of Resolution #5 of 2020 - Transfer of Funds - Impact to General

The Chairman asked the Board to consider motion to approve the following Resolution #5 of 2020:

BE IT RESOLVED that \$25,000 be transferred to the General Fund from the Impact Fee Fund pursuant to the 2020 General Fund Budget as adopted on December 10, 2019.

The motion was made by Charles Hickman and seconded by Walter Stout. Motion carried. (See Resolution Book for complete Resolution.)

b. Adoption of Resolution #6 of 2020 - Transfer of Funds - Fire Companies

The Chairman asked the Board to consider motion to approve the following Resolution #6 of 2020:

BE IT RESOLVED that a total of \$12,100 be paid in the appropriate percentages, to the Waynesburg-Franklin Township Fire Company (79%) and to the Amwell Township

Fire Company (21%) from the Fire Fund pursuant to the 2020 Fire Fund Budget as adopted on December 10, 2019.

The motion was made by Charles Hickman and seconded by Walter Stout. Motion carried. (See Resolution Book for complete Resolution.)

c. Approval of 2021 Final Budgets

The Chairman asked the Board to consider a motion to approve the 2021 Final Budgets, (See Minute Book file), for the various township accounts, with minor changes to the proposed budgets which were approved at the budget workshop meeting on November 16, 2020.

d. Adoption of Resolution #7 of 2020 – Tax Levies for 2021

The Chairman asked the Board to consider a motion to adopt Resolution #7 of 2020 which establishes the tax rates for the General, Machinery and Fire Funds for the year of 2021. The tax rates for 2021 will remain the same as they were for 2020. In accordance with Sections 3205 and 3208 of the Second Class Township Code, the millage on each \$1,000 of assessed value, and the cents on each \$100 of assessed value are as follows:
