MOTIONS

SECURITY

- 1. There were twelve (12) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of November 2020.
- 2. The facility issued eighteen (18) major misconducts and twenty-two (22) minor misconducts for the month of November 2020.

TREATMENT

- 1. We currently have no volunteer or outside programs being conducted at the facility.
- 2. The Lions Club has again graciously provided a Christmas Tree to the facility.

STAFFING AND TRAINING

 Officer's Hixenbaugh, Six, and Roberts have completed the PA DOC Training Academy as of 12-16-2020, a day earlier than scheduled due to the predicted weather conditions for the Harrisburg area.

MAINTENANCE

- 1. Huckestein Mechanical has installed the last Trane RTU circuit compressor on the main roof.
- 2. The new Water Tank was installed in the Laundry on 12-10-2020 along with Cummins Diesel replacing the solenoid on the Main Generator. It is noted the Main Generator fired on its own on Wednesday as required.
- 3. A total of six (6) bids were received yesterday from contractors in regards to the roof replacement project.

FINANCIAL REPORT

- 1. The November assessed revenue report generated from the Greene County Central Booking Center was \$4,375.00 with \$3,047.42 being an actual paid return for the month.
- 2. We have deposited \$580.00 for Work Release Inmates and \$ 280.00 for Weekend sentenced Inmates totaling \$860.00 for November 2020.
- 3. Fayette County currently owes \$100.00 in rental fees for the month of November.
- 4. The total revenue received for November was \$ 3,907.42
