April 13, 2021

Call to order at 3:00 p.m. by facilitator Frank Basile, Chairman. Board member's present: Ronald Howard and Mickey Lemley with secretary, Chris Jarrell. Pledge to Flag

Public in Attendance: None. Public Comment: None received.

Bid Opening: Bids will be opened for stone and fuel. Bid tally sheet is attached. Laurel Aggregates bid was opened first. Their bid was a total of \$56,700.00. Greer Limestone was opened next. Their total bid was \$45,920.00. Greer did not bid for Rip Rap and each category was higher. A motion was made by Mickey Lemley seconded by Ron Howard to award the bid to Laurel Aggregates. One bid was received for fuel. A bid was presented by Bruceton Petroleum at the index price of \$1.2085 for a total of \$6042.50. A motion was made by Mickey Lemley seconded by Ron Howard to award the bid to Bruceton Petroleum. Vote: All in favor.
