The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the first-floor meeting room of the County office building. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Chief Clerk Jeff Marshall, Sarah Penich, Ami Cree, Warden John Kingston, Marcus Simms, and Dave Russo

### **MOTIONS**

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the April 22nd 2021 Prison Board meeting. Vote unanimous.

### **SECURITY**

1. There were ten (10) reportable Extraordinary Occurrence Report (EOR) submitted to the Pennsylvania Department of Corrections for the Month of April 2021.
2. The facility issued twenty-eight (28) major misconducts and twenty-five (25) minor misconducts for the month of April 2021.

### **TREATMENT**

### **MAINTENANCE**

1. On 052521 at or about 1700 hours, I met with the Roofing Contractors for a debriefing on their finalization of the roofing project. They had completed final adjustments and began the removal of their heavy equipment from facility grounds following a site inspection and inventory of materials. They expressed their overall satisfaction with on-site support during the project and I expressed our satisfaction with the quality of the work performed and their attention to any needs or concerns we had during each stage of the project.
2. The Cemetery located on Portal Road off of Route 218 has been cut and trimmed.
