### **MOTIONS**

 Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the May 27<sup>th</sup> 2021 Prison Board meeting. Vote unanimous.

## **SECURITY**

- 1. There were four (4) reportable Extraordinary Occurrence Report (EOR) submitted to the Pennsylvania Department of Corrections for the Month of May 2021.
- 2. The facility issued nine (9) major misconducts and fifteen (15) minor misconducts for the month of May 2021.

# **TREATMENT**

1. We are in the process of continuing the vaccination of our newly received Inmates. Terry Wiltrout of the Washington Health System has contracted through McCracken's to provide the Johnson and Johnson. We have scheduled six (6) vaccinations for 061821.

2. Inmate haircuts were conducted on 061521.

#### **STAFFING AND TRAINING**

- 1. On 061121, Lieutenants Nilson and Kirby completed their Taser Instructor certifications along with a re-certification for Deputy Warden Cline, additionally as of 052521 both Lieutenants have achieved Instructor status for Sabre OC.
- On 061621, Deputy Warden Cline and Lieutenants Lantz and Nilson attended Supervisory Development training conducted by the Human Resources Department.

### **MAINTENANCE**

- 1. The Roof Contractors returned on 061421, 061521 and 061621 to paint the metal roof and the trim.
- 2. The Holding Cell project being developed in the former non-contact visiting continues with the construction of the unit doors. When finished each holding cell will have video surveillance capabilities upon completion. Two of the finished cells will contain handcuff benches and the third larger cell will be utilized for alternate housing and or specific needs assessments.
