Drug & Alcohol Program Updates – John Fox

- a. Case Management – John gave a brief update on case management and the March's data numbers. Lori Maley discussed the trends that the Care Center has been seeing.
- b. Treatment needs Assessment –Treatment Needs Assessment was submitted on time. The assessment touched on emerging trends from the County, Jail and Providers and the goals for the next 5 years: Continual improvement of the Warm Hand Off, Increase Recovery Activities/Capital in the County, by year 5 a Recovery Center.
- c. Prevention/Gambling – John gave an updated on the PA Stop Campaign, the purchase of a billboards and the Geofencing at Waynesburg University and all 5 school districts. March was Problem Gambling Awareness Month. Central Greene School District called about wanting an 8-week

summer project. Drug Take Back Day is April 24th there will be a drive through at the fairgrounds for drop off as well as a Naloxone distribution. A Townhall Meeting is scheduled for May 26th.

Comments/Public Comments – Lori Maley from the Care Center mentioned that she is glad to have the Center of Excellence up and running. Currently have 32 people enrolled.

Announcements – George Blystone announced the first Recovery Meeting would be Tuesday April 13th at 1:30 pm at Steps Inside. The discussion will be about Housing.
