Call to order at 6:00 pm. Pledge to Flag. Facilitator: Frank Basile, Chair. Board member's present: Ronald Howard and Mickey Lemley with Chris Jarrell, Secretary.

Public in Attendance: Dennis Makel, Solicitor, Josh & Megan Brozik, Francoise Blachere.

Public Comment: Josh Brozik addressed the Board regarding property he owns on Calvert Hill Road. Mr. Brozik stated that he has had trees pushed over, berries damaged, snow plowed in front of gate and dirt/garbage dumped on his property. The American Rescue Funds check has been received in the amount of \$73,373.12. The funds need to be put in a separate bank account. A motion was made by Mickey Lemley seconded by Ron Howard to authorize Christine Jarrell to open a separate checking or savings account at First Federal of Greene County. Said account will require 2 signatures. Authorized signers are Frank Basile, Mickey Lemley, Ronald Howard and Christine K. Jarrell. Vote: Approved.

Widmer Engineering has presented a proposal for the Legion Field Walking Track. Their proposal is \$8500 for the engineering work and \$1500 for the cost to locate the pins for the property boundaries for a total of \$10,000. After discussion, a motion was made by Mickey Lemley seconded by Ron Howard to approve Widmer Engineering's proposal. Vote: All in favor.
