Vision

We envision people in Greene County having the choice to live where they want to live in affordable, safe, and comfortable housing. This includes:

- Adequate single family units;
- Supportive housing services;
- Community infrastructure and public transportation;
- Sidewalks, green spaces, and recreational areas;
- Adequate “low income” and “subsidized” housing;
- Employment leading to more housing options; and
- Education of residents regarding credit, debt, and home ownership.

Mission

The mission of GCHOP is to create safe and affordable housing solutions to meet the needs of Greene County residents by:

- Addressing the housing needs of priority populations;
- Assessing all housing related services, resources, and supports;
- Collaborating and coordinating existing resources to maximize impact;
- Accessing a mixture of public and private funding;
- Educating younger and older adults about good credit and home ownership; and
- Advocating for legislative changes that impact housing.
