### SECURITY

1. There were eight (8) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of September 2021.
2. The facility issued twenty-nine (29) major misconducts and twenty-five (25) minor misconducts for the month of September 2021.
3. The average daily population for September was seventy-nine (79) with seventy (70) being the lowest number and ninety-four (94) being the highest.
