November 18 2021

The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the bottom-floor of the 4-H Building at the Greene County Fairgrounds. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Jeff Marshall, Ami Cree, Marcus Simms, Jerad Cline and John Kingston.

MOTIONS

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the review of agenda items from the October 21st 2021 Prison Board meeting based on members review via e-mail submission due to the cancelation of on-site assembly. Vote unanimous

SECURITY

1. There were ten (10) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of October 2021.
2. The facility issued thirteen (13) major misconducts and thirty-six (36) minor misconducts for the month of October 2021.
3. The average daily population for October was eighty (80) with seventy-three (73) being the lowest number and eighty-nine (89) being the highest.

TREATMENT

1. For October 2021, Men's Ministry was conducted on the 5th, 12th, and 26th and the Women's on the 11th, 18th, and 25th.
2. Haircuts were conducted on October 20th.

STAFFING AND TRAINING

1. Casual Corrections Officers Robert Rush and Robert Wilson have started their respective orientation phases and Officers Sokol and Fox are scheduled to attend the DOC Training Academy on November 29th 2021.

3. Washington County still owes \$8,850.00 for the month of August and \$7,950.00 for the month of September in regards to rental fees. I have contacted Warden Fewell and asked him to address this with his County Administration.
