Mr. Lash advised that some improvements were needed around the corner post in the Livestock Arena Barn. Mr. Belding asked Mr. Lash to send a letter to the Commissioners on how he wanted to fix it and they would approve it.

Ms. Stephenson advised the Fair Board that the PSACF had cancelled their convention for Hershey in 2021. There would be a Board Meeting though that she would be attending.
