It will be a process for the lawyer to try to find all owners of the surface coal rights for signatures and for everyone to reach an agreement. It is uncertain how long this process will take. The process of Barbetta's also has uncertainty in regards to the surface coal rights. Mr. Schweiger asked for the board's insight to moving forward with the Cree application. Mr. Orndorff stated how the Cree

Mr. Schweiger asked the board if there were any suggestions for changes to the program for the seven-year review. Mr. Ordnorff asked about the timeline for reviewing farms for compliance. Ms. Snider explained there is a two year rotation with the farms for this process.

A motion was made by Richard Thistlethwaite to send the seven-year review to state. James Willis seconded. (Motion passed)
