The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the first-floor meeting room of the County Office building. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Jeff Marshall, Warden John Kingston, Ami Cree, Marcus Simms, and Judy Snyder.

MOTIONS

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the meeting minutes from the January 20, 2022 Prison Board meeting. Vote unanimous.

SECURITY

1. There were nine (9) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of January 2022.
2. The facility issued eight (8) major misconducts and twenty-six (26) minor misconducts for the month of January 2022.
3. The average daily population for January was sixty-eight (68) with sixty-four (64) being the lowest number and seventy-two (72) being the highest.

TREATMENT

1. There were no outside groups or volunteers permitted during the month of January 2022 due to the increase in COVID positives within the County. This restriction was terminated February 1st 2022.

2. Full Time Corrections Officer Nick Jones started on 1-27-2022.

5. Corrections Officer Trainee Robert Wilson resigned as of 2-14-2022.

1. The January assessed revenue report generated from the Greene County Central Booking Center was \$ 4,900.00 with \$1,387.24 being the actual paid return.
