#### **CALL TO ORDER:**

- 1. Ben McMillen called the meeting to order at 3:34 p.m.
- 2. Kevin Paul made the motion and Don Chappel seconded to approve the April 13, 2022 meeting minutes. Vote was unanimous.

#### **ACCOUNTS RECEIVABLE**

 Kevin Paul reported the ending balance for the Hotel/Motel Tax account at \$179,600.85 as of April 29, 2022. The TPA Fundraising and TPA Money Marketing Savings accounts were not received prior to the meeting.

#### **ACCOUNTS PAYABLE**

1. Blair Zimmerman made the motion and Deneen Rhodes seconded to approve the May 11, 2022 Disbursement Request (Attachment 1) totaling \$15,428.69. Vote was unanimous.

### **DIRECTOR REPORT**

- 1. JoAnne Marshall shared that Emma Herle's last day with us was Friday, April 29<sup>th</sup>, but she is interested in continuing videography freelance opportunities with us. Abigail Phillips and Jesse Cain are our two summer interns and have already been at work learning and preparing content.
- 2. The Hammer-In Festival was well attended despite the weather and the re-dedication ceremony went well. Dan Bazzoli was also in attendance and shared that the Machine Shop was an incredible historical asset for our county.
- The Mon Valley Trailblazers are creating a walking tour of Waynesburg for the American Volkssport Association using Waynesburg Prosperous & Beautiful's historic walking tour as a template. They are tentatively scheduling a walking event for the September 10 to coincide with 50s Fest.
- 4. Tourism Week at the Welcome Centers was a good opportunity to reconnect with the staff at both the I70 Welcome Center and I79 Welcome Center. The I79 Welcome Center is in need of updated graphics to highlight Greene County. Liz Menhart, Casey Durdines, and Blair Zimmerman also were able to attend the Proclamation presented by the Greene County Commissioners.

## **COMMITTEE REPORTS**

### **Advertising**

1. Liz Menhart made the motion and Kevin Paul seconded to hold the Tourism Minute radio spots through Broadcast Communications during the 8am hour on Mondays, Wednesdays and Fridays on WANB Radio and during the 7am and 5pm hours on Tuesday and Thursdays on WKVE. The radio spots will run from May 16 to October 28 at \$20 per spot for a total of \$3,360. Vote was unanimous.

- 2. Blair Zimmerman made the motion and Courtney Hursey seconded to acquire Package 2B through the VisitPA Cooperative Marketing Program for 3 months at \$3,000 per month with VisitPA contributing an additional \$7,000 per month. The package includes online video and google responsive display ads. Vote was unanimous.
- 3. Courtney Hursey made the motion and Dan Bazzoli seconded to acquire the Page 3 ad of the Dominion Post's Guide to Summer at \$1,250. If the spot is already reserved, either the Back Page or a full-page ad would be substituted. Vote was unanimous.
- 4. JoAnne Marshall shared that the 2022 Official Visitor Guides have been received and over 12,000 have been distributed to our PA distribution program, Pittsburgh's distribution program, and by direct request. Requests will continue to be fulfilled.
- 5. JoAnne Marshall reported that the Car Show Brochure is at the printer and anticipated to arrive within the next week. The request list currently stands at 850 addresses. To expedite the timeline, nine rolls of stamps will be obtained and brochures will be sent out immediately.
- 6. Don Chappel made the motion and Kevin Paul seconded to hold the #DineGreene Challenge in July and August, the Photo Contest in September and October, the Hospitality Awards in November, and the 12 Days of Christmas promotional campaigns. Vote was unanimous.
- 7. JoAnne Marshall provided several updates:
  - a. To continue growing the reach, engagement and content of restaurant options in Greene County restaurants, Paige Livingston is working on a freelance video project proposal.
  - b. Images were submitted for possible inclusion in VisitPA's 2023 Happy Traveler Guide.
  - c. The Waynesburg University photo contest was overall a success. The template with some modifications will work to holding a photo contest for the public.
  - d. The Bandwango pass project is slow for implementation due to the time involved to recruit participation from restaurants.
