- 2. Don Chappel made the motion and Dan Bazzoli seconded to approve a photo training workshop on Wednesday, March 9. Cost is free for partners and \$10 for non-partners. Vote was unanimous.
- 3. JoAnne Marshall reported that the Google DMO program followed up on prior questions and will be sending out the Pixel phone along with a follow-up training. The results from their audit added more than 63 pieces of missing business information and the listings for Greene County are now 62% complete versus the 50% at the initial audit. Photos submitted by us were uploaded to Google and as of this morning had 1,453,472 views.
- 4. The Bandwango project had an issue in testing that prohibited communication between Android devices and the Google map app. Initially, Bandwango did not believe it was an issue on their end but they resolved the problem in their coding over the weekend. At this time, we need to continue testing the passport to find any other problems.
- 5. The monthly e-blast titled "Destination Greene" was sent out to over 4,500 recipients was sent out this week highlighting Valentine events, shopping and wedding venues.
