Resolution 8-2022 – a request was received from Gary & Michelle Lewis in regards to closing a portion of Martin Street. Our Solicitor has prepared a Resolution renouncing any interest in said alley. Mr. & Mrs. Lewis can take the Resolution to their attorney for further assistance in closing said portion. Motion by Tom Brookover seconded by Ron Howard to approve the Resolution. Resolution 9-2022 – Act 57 of 2022 amending the Tax Collection Law. This new law requires taxing districts to waive late fees for property purchased during a year and the new owner did not receive the tax bills. Discussion regarding Act 57: The Tax Collector, Christine Jarrell, states that she is very concerned about how this is going to work. The Tax Collectors are not notified of property sales and/or deed transfers. Who is going to report to them? There are stipulations as to who will get

the discount. More information will be forthcoming from the PA State Tax Collectors Association. Motion by Ron Howard seconded by Tom Brookover to approve Act 57. Vote: All in favor.
