MOTIONS

1. To approve the minutes from the November 2022 Prison Board meeting.

SECURITY

1. There were seven (7) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of November 2022
2. The facility issued Twenty-Four (24) major misconducts and Thirteen (13) minor misconducts for the month of November 2022.
3. The average daily population for November was Seventy-One (71) with Sixty-Seven (67) being the lowest number and Seventy-Seven (77) being the highest

TREATMENT

1. During the month of November, Landmark Baptist Church conducted Four (4) men's bible study groups. Celebrate Recovery conducted Six (6) men's bible study groups. First Assembly Church conducted Four (4) women's bible study groups.
2. During the month of November, the facility hosted two (2) Narcotics Anonymous meetings.
3. During the month of November, haircuts were conducted on two (2) occasions.
