- 3. Don Chappel made the motion and Courtney Hursey seconded to purchase the Bronze sponsorship in Business View Magazine's Greene County Airport editorial piece for \$1,550. Vote passed with Blair Zimmerman abstaining.
- 4. Liz Menhart made the motion and Deneen Rhodes seconded to purchase a full-page ad in VisitPittsburgh's 2023 Official Visitor Guide for \$10,000. Vote was unanimous.
- 5. Don Chappel made the motion and Blair Zimmerman seconded to accept the low bidder of the print bids for 20,000 quantity of the 40-page (including cover) 2023 Greene County Official Visitors Guide.

## **Fundraising**

1. JoAnne Marshall shared that due to timing and availability, the planned promotional campaigns of #ShopGreene, #DineGreene, and 12 Days of Christmas will be postponed until next year.

#### Hotel/Motel Tax

1. Hotel occupancy for September 2022 was 56.4%, average daily room rate was \$93.48, the revenue per available room was \$52.74, and the number of rooms sold were 6,431.
