SECURITY

1. There were Four (4) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of January 2023
2. The facility issued Twenty-one (21) major misconducts and Twenty-five (25) minor misconducts for the month of January 2023.
3. The average daily population for January was Sixty-eight (68) with Sixty-Two (62) being the lowest number and Seventy-nine (79) being the highest

TREATMENT

1. During the month of January, Landmark Baptist Church conducted Four (4) men's bible study groups. Road to Recovery conducted Five (5) men's bible study groups. First Assembly Church conducted Three (3) women's bible study groups.
