 - All Polling places are confirmed.
 - Working on the last precincts for poll workers. Clarksville, Dunkard #1, Greene, Morgan Chart/TGDN. Have some floaters that should be able to fill most of the positions, need 3 more bodies.
 - William Penn Printing are printing the in-person ballots, Tentative delivery is May 4th.
 - Poll worker classes conducted for the 24th, 25th and 26th of April.
