**MINUTES OF MORGAN TOWNSHIP  
April 4, 2023**

**CALL TO ORDER:** At 4:00 p.m. Jeff Sholtis, Chairman, called the regular monthly meeting of the Morgan Township Supervisors to order in the municipal office building located at 1019 Third Street Extension, Mather, Greene County, Pennsylvania. The meeting opened with the pledge to the flag.

**ROLL CALL:** Supervisors Jeff Sholtis and James Gayman. Supervisor Shirl Barnhart was absent due to vacation. Also attending the meeting was Stacy Sholtis, Kari Goldman, Clint and Philomena Blaney, Carl and Sandy Kibler, Dave Brichetti, Sherry Buljat, Diane Tedrow, Solicitor Dennis Makel and Secretary/Treasurer Relda Litten.

**APPROVE MINUTES:** A motion was made by Mr. Gayman with a second from Mr. Sholtis to approve the minutes of the March 7, 2023 meeting and the motion carried.

**PUBLIC COMMENTS:** Ms. Buljat mentioned that the vehicles are still on Third Street. Mr. Brichetti gave the Supervisors a letter from Pat Mullen who owns 304 & 306 Third Street granting permission for the Engineers to go onto his property to do an inspection at 308 Third Street.

Mr. and Mrs. Kibler spoke about issues they are having with double Street Light assessment bills.

Ms. Golden stated that on the Township audit, there are different figures in Real Estate than what she turned in.

**REPORTS:** Roadmaster: Mr. Sholtis gave his report for the month. The township has cleaned ditches and was called out to remove trees three times over the heavy winds.

**LEGAL:** Mr. Makel presented the supervisors with several heavy hauling agreements which were accepted with a motion from Mr. Gayman and seconded by Mr. Sholtis and the motion carried with all in favor. EQM wants to have their bond released on several roads but the Supervisors have not inspected them, so the request was tabled till next month.

**CODE ENFORCEMENT OFFICER:** Mr. Gordon was not present at the meeting, but turned in his report.

**ORDINANCES, RESOLUTIONS AND LOT SPLITS:** None

**UNFINISHED BUSINESS:** The Tax Collector has withdrawn her resignation.

**NEW BUSINESS:** Clean Up Days will be April 28 and 29 from 7 a.m. to 3 p.m. each day with Jefferson Borough going to participate. A motion was made by Mr. Gayman, seconded by Mr. Sholtis to allow Jefferson Borough to participate on Clean Up Days with the township and have the borough pay one third of the cost of the dumpsters and provide help and the motion carried with all in favor.
