Meeting Minutes

March 7, 2023

CALL TO ORDER: At 5:30 PM, President Dawn Wood called the meeting of the Jefferson Borough Council to order in the Morgan Township Office Building at 1019 Third Steet Extension, Mather, Greene County, Pennsylvania. The meeting opened with the Pledge of Allegiance.
