**MINUTES**  
**Meeting, May 9, 2023**

**CALL TO ORDER:** At 10:00 a.m. Jeff Sholtis, Chairman, called the rescheduled monthly meeting of the Morgan Township Supervisors to order in the municipal office building located at 1019 Third Street Extension, Mather, Greene County, Pennsylvania. The meeting opened with the pledge to the flag.

**ROLL CALL:** Supervisors Jeff Sholtis and James Gayman were present. Supervisor Shirl Barnhart was absent due to illness. Also attending the meeting was Stacy Sholtis, Sandy and Carl Kibler, Tax Collector Kari Golden, David Saunders, Susan Nelson, Solicitor Dennis Makel and Secretary/Treasurer Relda Litten.

**APPROVE MINUTES:** A motion was made by Mr. Gayman with a second from Mr. Sholtis to approve the minutes of the April 4, 2023 and the motion carried.

**PUBLIC COMMENTS:** Ms. Kibler wanted to know if anything has been done on her street light assessment problem. Mr. Makel will schedule a conference call later on this week between himself, the Kiblers and Marcia Sonneborn who handles the street light accounts for the township.

Ms. Sholtis asked if anything has been done about the car with no insurance parked at 234 Second Street in Mather.

**REPORTS:** Roadmasters: Mr. Sholtis gave the report for the month. The township has been getting #8 stone in the lot preparing for tar and chipping soon. Roads are being boom mowed and side deck mowed. They will finish up leaf blowing the ditches today. A phone call was received from the PA Boat and Fish Commission regarding a complaint about a tree on Kennel Road and found it was fine. Cold patching has also been done and a paving project will be scheduled soon.

Three dumpsters were used for clean up days. Jefferson Borough went in with the township for the cleanup with three council members helping and also Mr. Makel. \$1,000 was received from Casey Durdines, representing EQT for the cleanup, too. It was decided that Jefferson Borough will pay one third of the cost of advertising and the dumpsters.

Legal: Mr. Makel stated the issue with the trailer at Jefferson Estates and Scott Smith has been resolved. The trailer will be removed and the township will be reimbursed for the cost of the Code Officer's extra hours on the case. There will be another hearing on the King case and the Kenny trailer on property at 308 Third Street in Mather will be removed.

Code Officer: Mr. Gordon was absent but turned in his report to the supervisors who looked it over.

**ORDINANCES, RESOLUTIONS AND LOT SPLITS:** None

**UNFINISHED BUSINESS:** None

**NEW BUSINESS:** The township received an invoice from EADS Group which does not have the \$1,800 that the township has already paid on their plus it needs to be broken down more. Mr. Makel will handle it.
