#### **MOTIONS**

1. Commissioner Betsy McClure made the motion and Controller Ami Cree the second to approve the minutes from the August, 2023 Prison Board meeting. Vote unanimous.

## **SECURITY**

- 1. There were Five (5) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of August, 2023
- 2. The facility issued Eighteen (18) major misconducts and Eighteen (18) minor misconducts for the month of August 2023.
- 3. The average daily population for August was Sixty (60) with Fifty-five (55) being the lowest number and Sixty-Nine (69) being the highest
