MOTIONS

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the September, 2023 Prison Board meeting.

SECURITY

- 1. There were Five (5) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of September 2023
- 2. The facility issued Twenty-Three (23) major misconducts and Eighteen (18) minor misconducts for the month of Sept 2023.
- 3. The average daily population for September was Sixty-One (61) with Fifty-Six (56) being the lowest number and Sixty-Four (64) being the highest
