

# **GREENE COUNTY PRISON BOARD**

**March 19, 2020**

*(live streamed and conference call)*

The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the first-floor meeting room of the County office building. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Ami Cree, Jeff Marshall, Sarah Penich, Gene Grimm, Marcus Simms, and Steve Barrett.

## **MOTIONS**

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the February 20th 2020 Prison Board meeting. Vote unanimous.

## **SECURITY**

1. There was one (1) reportable Extraordinary Occurrence Report (EOR) submitted to the Pennsylvania Department of Corrections for the Month of February 2020.

2. The facility issued fifteen (15) major misconducts and twenty-three (23) minor misconducts for the month of February 2020.

## **TREATMENT**

1. For February we conducted six (6) Adult Education classes, six (6) Bible Study classes from Landmark Baptist Church, two (2) Domestic Violence groups, one (1) Celebrate Recovery group, four (4) Axiom Family sessions, one (1) Narcotics Anonymous group, two (2) Alcoholics Anonymous groups, four (4) Walk With Jesus Daily (WWJD) groups, and eight (8) Drug and Alcohol assessments were conducted.

## **STAFFING AND TRAINING**

1. We currently have four (4) Casual Corrections Officers in training.

## **MAINTENANCE**

1. The men's work crew has been supporting County Maintenance in the roofing project at the County Airport, however due to the current restrictions their duties have been confined to facility cleaning and daily decontamination procedures.

**FINANCIAL REPORT**

1. Fayette County still owes \$2,000.00 for February and currently owes \$1,900.00 for March 2020.
2. Deposits totaling \$1,620.00 have been made with the Treasurer’s Office for February with \$ 660.00 for work release and \$960.00 for weekend fees.
3. The February assessed revenue report generated from the Greene County Central Booking Center was \$4,900.00
