TREATMENT

1. Prior to the restriction of entrance of visitors to the facility, the following programs or sessions were conducted for the Month of March.

Two (2) Landmark Baptist Church Bible Study classes, One Axiom Family session, two (2) Walk with Jesus Daily (WWJD) groups, One (1) Alcoholics Anonymous group, Two (2) Drug and Alcohol assessments, and Two (2) Mental Health assessments.

1. The men's work crew continues to work on grounds and within the facility.
