MINUTES

Walter Stout, Chairman, called the meeting to order at 7:00 PM followed by the Pledge of Allegiance.

In attendance were Supervisors Walter Stout, Charles Hickman, Troy Smith; and Secretary Diane Headlee. Also in attendance were several interested township residents.

I. Requests to Address the Board/Public Comment

Resident George Bissett asked whether a zoning permit had been approved and issued to his neighbor, Douglas Robinson, who is constructing a waterfall type porch to the front of his house. The porch has been built inside the five (5') foot side-yard boundary limit with Bissett's adjoining property. Mr. Stout said the township is aware of the violation, and has sent the Building Codes Enforcement officer to assess the situation. Mr. Stout said it appears that Mr. Robinson has three choices regarding the issue, to move the porch to get it outside the required minimum side yard dimensions, to purchase some property from Mr. Bissett to move the property line, or to request a hearing before the Zoning Hearing Board for a Variance to the Ordinance requirements. Mr. Bissett was informed that should a variance hearing be requested by Mr. Robinson, he would be informed as to day, date and time so that he could attend and testify and comment on the matter.

II. Correspondence and Reports

1. Received Correspondence:

- In accordance with the Pennsylvania Municipalities Planning Code, being a
 contiguous municipality, we have been provided with a copy of Franklin
 Township's proposed Comprehensive Plan for review. For the next 45 days, any
 Washington Township resident may stop in the township office to review the
 proposed plan.
- Received notification from Casey Durdines, EQT regarding a spill at the Habe pad.
 DEP was notified and it is contained.
- We have closed the office to the public due to the COVID-10 virus. We continue to work behind locked doors and request that people call before coming to the office.

 The Board met to re-organize on March 5th and also to review and comment on a request for a Special Exception prior to action by the Township Zoning Hearing Board.

3. Zoning Board:

 A meeting of the Board will be held on Thursday, March 26th to conduct a hearing on the request by Kristy and Nathan Borovichka for a Special Exception in an A-1 (Agriculture use) district, for a Contractor's Yard.

 The Park Board met in February to discuss the upcoming park activities. The Board decided not to sponsor the Township Yard Sale due to scheduling conflicts and low participation in previous years.

5. Roadmaster's Report

• Mr. Hickman reported the road crew did some electrical upgrades in the shop area, equipment maintenance, plowed and cindered township roads, cleaned ditches on various roads, and removed trees and limbs from various roads. The road crew worked on stream bank stabilization on Greene Valley Road, drug and rolled Gray Run and Edgar Hill Roads. Craig's Run has re-opened after being closed for 2 ½ months for slip repairs. Nine slip areas were completed by Hayden Excavating under an EQT contract.

d. Opening/Awarding of Bid – Boom-Arm Mower

Pursuant to action by the Supervisors at the February 11, 2020 meeting, specifications were prepared and a request for sealed bids was advertised for a new boom arm-mower to replace the Alamo Machete mower which had reached the end of its useful life. The new mower will be installed on the township's Case tractor. Subsequently, one bid was received from Mo-Trim Inc., in the amount of \$41,382.80, (see Bid file). The mower, as bid, meets all of the specifications, as advertised. Therefore, the Chairman asked the Board to consider a motion to award the received bid of \$41,382.80 for a new 21' Mid-Mount Boom Arm Mower to be installed on the township's Case tractor to Mo-Trim, Inc. Payment will be from a combination of Impact Fee funds as well as the Machinery Fund. The motion was made by Troy Smith and seconded by Charles Hickman. Motion carried.
