INSTRUCTIONS TO VOTER

1. TO VOTE YOU MUST BLACKEN THE OVAL (●) COMPLETELY.
- An oval blackened to the right of the name of any candidate indicates a vote for the candidate.
2. To vote for a person whose name is not on the ballot, you must blacken the oval (●) to the right of the line provided and write, print or stamp the name in the blank space provided for that purpose.
3. If you make a mistake, **DO NOT ERASE**. Ask for a new ballot.
4. **WARNING** - If you receive an Absentee/Mail-In Ballot and return your voted ballot by the deadline, you **MAY NOT** vote at your polling place on Election Day. If you are unable to return your voted ballot by the deadline, you may vote a regular ballot at your polling place on Election Day if you surrender the ballot and the envelope containing the voter's declaration to the Judge of Elections to be spoiled. You will vote a Provisional Ballot if you do not surrender your balloting materials.
